4. The number of vendors shall be limited. Vendors will be accepted on first come, first paid basis.
5. Delivery, handling, erecting, and removal of booth, display, equipment and material (i.e. trash) is the responsibility of the vendors.
6. Insurance must be obtained at your own expense. The Southern Arizona Harley Riders, MC assume no risk or responsibility for loss or damages.
7. No drugs or drug paraphernalia will be allowed or sold during this event.
8. All vendors are required to have their own fire extinguisher, generator and water.
9. Food vendors must have Cochise County Food handlers permit if required.
10. Vendors spot \$50.00 and are authorized **3 people** per booth. All others are \$15.00 per person.
